Executive Summary

Authorizing a \$3,249,165.00 construction contract with SHEDIGS IT, LLC, for the Water Main Replacement in the Area of Holmes Road and Blue Ridge Boulevard to the Prospect Avenue Elevated Storage Tank project; and authorizing a maximum expenditure of \$3,554,000.00.

Discussion

Project Justification

The Water Services Department is undertaking this construction project to improve distribution system reliability, increase hydraulic conveyance capacity, and support fire protection to replace aging, break-prone cast iron (CIP) water mains with ductile iron pipe (DIP).

Project Description

This Project in general consists of replacing approximately 7,000 linear feet (LF) of 6-inch, 8-inch, and 12-inch break-prone or obsolete water mains within the project limits, generally defined as Holmes Road and Blue Ridge Boulevard to the Prospect Avenue Elevated Water Storage Tank, in Kansas City, Jackson County, Missouri.

The specific mains to be replaced and other distribution system improvements within the project limits consist of the following:

 Replace 6-inch CIP, 8-inch, and 12-inch CIP water mains with 16-inch DIP along E. Blue Ridge Boulevard from Holmes Road to the Prospect Avenue Water Storage Tank (near vacated Prospect Avenue).

The work will include the transfer of customers' water service connections from existing water mains to new water mains. The amount of this contract is \$3,249,165.00.

The term of this contract is 300 calendar days.

Solicitation

This project was advertised in accordance with the City's requirements. Public bids were opened on October 24, 2023 with 4 bidders responding.

MBE/WBE Goals

CREO KC established goals of 11% MBE and 11% WBE on this project on April 17, 2023 as part of the CREO KC Annual Goal Program.

Awardee/Subcontracting Participation

SHEDIGS IT, LLC was selected for this project as the lowest, most responsive, and most responsible bidder with a contract amount of \$3,249,165.00, with subcontracting participation of 11% MBE and 12% WBE.
