<p>Discussion</p> <p>The NW Prairie Road South of NW 64th Street Project realigns NW Prairie View Road to the existing N. Chatham Avenue Signalized Intersection. This project includes sidewalks, bike lanes, storm sewer, sanitary sewer, detention basin relocation, retaining walls, and LED Street lighting. This project also includes MoDOT designed on and off ramp adjustments for the I-29/NW 64th Street Interchange.</p> <p>The supplemental funding agreement and the road relenquishment agreement will allow the state to contribute an additional \$1,500,000 towards the project cost to pay for the improvements within the interchange and allow the project to move forward with construction in 2019.</p> <p>Is it good for the children? Yes</p> <p>How will this contribute to a sustainable Kansas City? It is sustainable by improving Northwest Prairie View Road to urban standards with curb, gutter, sidewalks that will connect to the commercial center north of Route 45 and the ATA I-29 service line.</p> <p>Project will also reduce traffic accidents and the associated delay and vehicle emissions caused by congestion at the I-29/Route 45 interchange with having the outer road and ramp terminal traffic signals so close together.</p> <p>Kansas City residents will be able to access the Tremont Square shopping district via bicycle or walking and reduced automobile emissions caused by substandard street network.</p>
