REGULATION NUMBERS 64946 THROUGH 64954 INSTALLATIONS

TO WHOM IT MAY CONCERN:

Pursuant to the authority granted in paragraph (b) of Section 70-38 of the "Code of General Ordinances of Kansas City, Missouri" and subject to the provisions thereof, traffic regulations are hereby made and adopted as follows:

Stopping, Standing and/or Parking shall be prohibited (as indicated) on the following street(s) and shall be added to the list as contained in **Section 70-530**:

Regulation Number	Location	Restriction
64946	N Corrington Avenue, west side, from a point 690 feet north of NE Parvin Road to a point 1205 feet north of Parvin Road	No Parking Anytime

<u>Parking</u> for longer than the <u>Time Limit</u>, as indicated below, during the hours and/or days indicated shall be prohibited. The time limit and effective hours and/or days shall be added to the list as contained in <u>Section 70-531</u>:

64947	20 th Street, south side, from a point 60 feet west of Walnut Street then west 84 feet	Three Hour Parking 7:00 AM to 6:00 PM Monday through Friday

64948	Broadway Boulevard, west side, from 8 th Street to a point 120 feet north of 9 th Street	Two Hour Parking 9:00 AM to 6:00 PM Monday through Friday
94949	Broadway Boulevard, west side, from a point 80 feet north of 9 th Street then north 40 feet	Fifteen Minute Parking 9:00 AM to 6:00 PM Monday through Friday
94950	Main Street, west side, from a point 175 feet north of 63 rd Street to 62 nd Terrace	Two Hour Parking
64651	Main Street, west side, from a point 150 feet north of 63 rd Street then north 25 feet	Fifteen Minute Parking

Reserved parking for <u>Physically Disabled Persons</u> is hereby established, as indicated below, and shall be added to the lists as contained in <u>Sections 70-534</u> and <u>70-535</u>:

Regulation Number	Location	Restriction
64952	Troost Avenue, east side, from a point 190 feet north of 44 th Street then north 20 feet	Accessible Parking
64953	Wayne Avenue, east side, from a point 45 feet north of 55 th Street then north 20 feet	Accessible Parking

A <u>Loading Zone</u> is designated at the following location(s), and shall be added to the list as contained in <u>Section 70-561</u>:

Regulation Number	Location	Restriction
64954	20 th Street, south side, from a point 48 feet east of Main Street then east 45 feet	Fifteen Minute Passenger Loading Zone

The locations affected by the above regulations will be marked in accordance with standards prescribed in the "Manual on Uniform Traffic Control Devices for Streets and Highways" and said regulations shall become effective five days after publication in The Daily Record.
