Executive Summary

Construction of public improvements in the Waldo Area at 75th & Wornall Road including Wornall Road from W. 73rd Terrace to W. 79th Street and W. 75th St. from Pennsylvania Ave. to Wyandotte St., improvements that include new concrete pavement, curb and gutter, sidewalks, traffic signals, street lighting, streetscapes, water main replacement and Green Infrastructure for storm water detention; authorizing a construction contract with Radmacher Brothers Excavating in the amount of \$13,966,712.10; and authorizing Amendment No. 3 for construction engineering services contract with Walter P. Moore in the amount of \$229,880.20 for a total contract price of \$1,558,582.10.

Discussion

This project has been several years in study, design, the ROW process with many City departments contributing to its success including Public Works, Water Services Department, Law and Finance Department. Wornall Road is a very important N-S corridor for the City and this section of Wornall Road improvements will continue to build on improvements south of 79th St. These improvements will last for many decades and are made possible by funding from PIAC, GO Bonds, and Federal Grants. The DBE Goal for this Street Reconstruction Project is 7% as established by MO DOT.

Service Level Impacts

Other Impacts

- What will be the potential health impacts to any affected groups? Reduced traffic congestion will have a positive impact on health by decreasing air pollution. Improved sidewalks and connections of the Trolley Track Trail will promote physical activity.

 A total of nine public meetings have occurred from 2018-2021 to engage the public and seek public input. These include Waldo Area Business Assoc., Southtown Council, and open meetings with the public.
