Brief Title

Vacation of the alley in between Oak Street to the west and Locust Street to the east in between E. 19th Street and E. 20th Street.

Details

Location:

Generally located in between Oak Street to the west and Locust Street to the east in between E. 19th Street and E. 20th Street.

Reason for Legislation:

To provide additional developable space for several apartments and amenities.

CITY PLAN COMMISSION

The City Plan Commission heard this case on November 20, 2018. The Commission recommended approval of the vacation with conditions.

BRIEF PROJECT DESCRIPTION

The area of land proposed for vacation is a north-south alley that is generally located on the southeast corner of 19th Street and Oak Street within the Crossroads area. The area to be vacated is not currently paved and there is dumping on both sides of the alley. The applicant intends to develop the site, constructing four new apartment buildings and renovating the existing building on the site. The preliminary plat and development plan were approved by Council on August 2, 2018. City staff supports this vacation.

Staff recommends approval of this vacation, subject to four conditions.

RECOMMENDATION:

Staff recommends approval of Case No. CD-ROW-2018-00118 with the following conditions:

1. That a utility easement is retained for all AT&T facilities or they be relocated at the expense of the applicant.
2. That a utility easement is retained for all Google Fiber facilities or they be relocated at the expense of the applicant.
3. That a utility easement is retained for all KCP&L facilities or they be relocated at the expense of the applicant.
4. That a utility easement is retained for all KCMO Water Services infrastructure or they be relocated at the expense of the applicant.
