

AMENDMENT #3
COOPERATIVE AGREEMENT FOR BICYCLE SHARING PROGRAM
BETWEEN
KANSAS CITY, MISSOURI AND BIKE SHARE KC

THIS AMENDMENT is made and entered into this 28th day of MAY, ^{2015 SKM} ~~2014~~, by and between the City of Kansas City, Missouri, a constitutionally chartered Municipal corporation (hereinafter referred to as "City"), and Bike Share KC, (hereinafter referred to as "Bike Share"). The parties amend the Agreement entered into on July 3, 2012 as follows:

Sec. 1. Sections Amended: The Agreement is amended as follows:

A. Delete and replace the following section(s):

a. Section 6, Subparagraph 1.

1. Program Operation.

a. The City shall provide Bike Share with staff assistance, as needed, in locating Program facilities. However, in no event is the City to assume any active role or responsibility for the operations of the Program, which shall remain entirely with Bike Share, nor shall the City be financially responsible for the Program, unless the City elects to fund maintenance services as provided in Section 5.1. of this Agreement.

b. Notwithstanding any other provision of this agreement regarding funding obligations, the City shall provide Bike Share with an amount not to exceed \$120,000.00 on or before April 30, 2016. These funds shall be used exclusively for the purchase of new bicycles and bicycle-sharing stations to be installed within the limits of Kansas City, Missouri. Bike Share shall provide the City with an invoice on the 15th of each month for any eligible purchases occurring in the previous calendar month for which it seeks reimbursement. Each invoice shall be on a form approved by the City. If said invoice(s) are approved, the City shall release equipment funds to Bike Share no later than thirty (30) days following approval.

Sec. 2. Sections not Amended. All other sections of the Agreement shall remain in full force and effect.

Sec. 3. Authorization. If the amount of the original Agreement plus the amount of any amendments to the original Agreement total more than \$257,000.00, City Council or Park Board approval is required.

Sec. 4. Effectiveness; Date. This amendment will become effective when all the parties have signed it. The date this amendment is signed by the last party to sign it will be deemed the date of this amendment.

Each party is signing this amendment on the date stated opposite that party's signature.
