<p>Specific Address</p> <p>The Redevelopment Project Area includes an area of approximately 25.74 acres more or less, generally located on the west side of N Green Hills Road between MO-152 and Barry Road, in Kansas City, Platte County, Missouri.</p> <p>Reason For Legislation</p> <p>This ordinance provides for the approval of Project 27, which allows for the implementation of the KCI Corridor TIF Plan. The Plan approved, provides for the expansion and improvement of the public infrastructure within the Redevelopment Area. Approval of the Project will provide for the collection of EATs generated by the Plan to be eligible to repay approved reimbursable costs.
