LEGISLATION IN BRIEF:

Calling for submission to the voters of Kansas City, at a special election to be held on November 2, 2021, a question to remove certain City property devoted to park use in the park system generally located on the west side Searcy Creek between 210 Highway and approximately NE 36th St and serves as right of way for parkway purpose; directing the City Clerk to notify the responsible election authorities of the election on or before August 24, 2021; and recognizing this ordinance as having an accelerated effective date.
