### Introduction

Community Improvement Districts (CID) have long served Kansas City to facilitate redevelopment and provide reinvestment in local communities through funding the provision of a variety of services. Approved by City Council, each CID must garner the support of a majority of property owners as well as property owners collectively owning more than fifty percent of the assessed value of property within the district. There are currently 90 separate CIDs within Kansas City, some of which are dedicated to providing community services and some of which are dedicated to remediating blight and capital improvements.

This report is prepared for City Council under the direction of Ordinance 210565, which was passed January 13<sup>th</sup>, 2022. Requirements for CID reporting originate in State statute, with additional requirements established by the City. This report includes two main sections: an aggregate summary of all CIDs, as well as an appendix identifying each specific CID and whether requirements were met. City staff were directed to prepare this report annually, indicating the degree of compliance of all CIDs related to the submission of annual budgets and annual reports, whether the work performed conformed to previous budgets, and whether the CID met the terms of its cooperative agreement with the City. Each CID was evaluated on the submission of the proposed budget for Fiscal Year 2024 (ending April 2024), as well as the submission of the annual report for Fiscal Year 2023 (ending April 2023). Staff sent out emails in mid-August, attempting to contact representatives of each CID in order to remind each district of State and City obligations.

# **Executive Summary**

In the second year of Community Improvement District (CID) reporting requirements, there was a significant improvement compared to the prior year especially regarding timeliness. This year 95% of CIDs submitted a proposed budget with 77% being on time while last year 80% of CIDs submitted a proposed budget with 64% on time. 93% of CIDs submitted an annual report with 83% submitted on time. This is compared to the previous year with 89% of CIDs submitting an annual report with only 64% being submitted on time. During Fiscal Year 2023 61% of CIDs submitted budgets that met all requirements and 60% of CIDs submitted annual reports that met all requirements. While this is just over half of the districts, in the previous year only 51% of CIDs submitted budgets that met all requirements and 11% of CIDs submitted annual reports that met all requirements.

The majority (91%) of CIDs provided both names and contact information of the board members. Of the CIDs that submitted annual reports, only two did not provide board member names or contact information. 93% of CIDs also provided their revenues and expenditures in the annual reports. Of the CIDs that submitted an annual report, 8% listed revenues of \$0.00 while 15% listed expenditures of \$0.00.

CIDs are created to provide services to the district, whether that be public or private services. These services can encompass a variety of tasks including, but not limited to, snow removal, blight remediation, and repayment of debts for previously provided services. According

to the annual reports, 72% of CIDs provided services to their Districts. Of the CIDs (21%) whose annual reports show no services being provided, 3% had not begun collecting revenues yet.

Most CIDs provided the dates of their FY 24 budget submittal and adoption, 90% and 91% respectively. Of annual reports submitted, almost all CIDs dated the reports with only one CID not dating the report. 48% of CIDs did not date their proposed budget submittals. For those CIDs that did not date their annual reports and proposed budgets, dates were taken from the file name assigned by the City Clerk.

One of the most significant non-compliant items was Districts' conformance to their FY 2023 budgets. 85 CIDs were required to submit both a FY 23 proposed budget and annual report, and only 42% of these Districts showed conformance to their budgets. 11% of Districts did not submit a FY 23 budget, so there was no way to judge their conformance. 9% of Districts were not conforming to their budget because of lack of detail in either their budget or annual report. We could not determine budget conformance for 28% of CIDs due to differences between their budgets and annual reports such as differing line items or line items being reported significantly over budget.

Confirming CID adherence to terms of their City cooperative agreements is difficult, as staff has been unable to locate cooperative agreements for 74% of CIDs. While this is the majority of CIDs, cooperative agreements have only been required since 2013 and only for CIDs engaging in improvements to public right-of-way or otherwise supporting business activities and economic development (per Resolution No. 120605). 30 current CIDs were formed prior to 2013. Staff has record of 22 cooperative agreements with eight of these agreements having been executed.

Of the 81 Districts that submitted a Fiscal Year 2023 annual report, they collected total revenues of \$31,678,616.57. There are seven Districts that collected revenues of greater than \$1,000,000 for the fiscal year. Eight Districts collected revenues between \$500,000 and \$999,999. 32 Districts collected revenues between \$100,000 and \$499,999. 25 Districts collected revenues between \$1,000 and \$99,999. Two Districts collected revenues between \$1 and \$999. Seven Districts stated they collected zero dollars in revenue.

#### **Previous Year Recommendations**

The previous report given to Council proposed two recommendations for their consideration. The first recommendation was to change the submittal date requirement of this report from on or around November 1<sup>st</sup> to on or around December 1<sup>st</sup>. Even though there was an increase in the number of CIDs submitting annual reports on time, there were still CIDs submitting reports into late October. Revising staff's report submission date would allow adequate time to supply a more detailed and thorough report to Council. Due to this recommendation, staff has drafted an ordinance to make this change.

The current ordinance requires contact information be provided for each CID board member. The second recommendation given to Council last year was to specify this contact information be provided in the form of an email address. Email addresses are a more convenient

and cost-effective form of communication than traditional mailing. While there was no change made to the ordinance, staff did request CIDs to provide email addresses for their board members' contact information and of those that submitted annual reports, they almost all complied. Of the two CIDs that did not provide email addresses, one CID has no activity nor board members and the other CID simply did not provide any board member information.

#### Recommendations

Even with the progress that has been made compared to year one, there are still further improvements for Council to consider.

- 1. The current ordinance outlines procedures for assessing fines to any CID that fails to submit its proposed annual budget and annual report within the required timeframe. This section of the ordinance includes an administrative citation and administrative hearing process which has yet to be implemented. The first step for implementation would require the City Manager to designate a staff person to administer these citations and to designate a hearing officer for the appeals of the administrative citations. Implementing the fines process will encourage the CIDs to submit the annual reports and budgets in a timely manner, which will in turn assist staff with completing the report for Council more efficiently.
- 2. Staff has come across the issue of reporting on defunct CIDs. There are multiple CIDs in Kansas City where the District or businesses within the District no longer exist but there is still a CID; for example, the I-70 and Blue Ridge Cutoff CID which is the location of the old Adams Mark hotel. Staff time is spent attempting to contact these CIDs for their reports and budgets and including them in this report. The current ordinance includes no language that would allow staff to dissolve these unused CIDs. Staff would recommend adding a section to the current ordinance to authorize staff to terminate CIDs after a specific period of inactivity and inability to contact the original petitioners.
- 3. The ordinance as written allows the City Auditor the right to examine or audit the records of the CID and that the CID make such records available to the City Auditor within ten (10) days after a written request for the same is made. Staff proposes having CIDs include documentation with the annual reports to demonstrate expenses are being used as reported in their annual reports, and more frequent random audits of the CIDs.
- **4.** One of the most significant non-compliant components of the annual reports was the Districts' conformance to their previous year's budget. Many CIDs had multiple line items on the financial portion of their annual reports that were not included on their budgets for the year. There was also a consistent issue of the values provided in annual reports being much higher than estimates from the proposed budget for the year. We recommend to the Districts they provide details in their proposed budgets as they will be reflected in their following annual reports. Using previous years reports to prepare their budgets could help provide a more accurate estimate of line items and appropriate values.

**0** (0%) reports were submitted over 60 days late (not counting non-submittals).

  - **14** (**16%**) Districts did not meet multiple requirements.
  - 6 (7%) Districts have no record of submitting an annual report.

- 2 (2%) Districts did not list board members or contact information.

- **6** (7%) Districts have no record of submitting an annual report.

#### **Services Provided:**

Of the **87** Districts required to submit an annual report for FY 23, **63** (**72%**) Districts state the services provided by the District during the fiscal year.

- 0 (0%) Districts provided services but did not specify what services were provided during FY 22.
- 18 (21%) Districts did not provide services.

Of the above 18 Districts, 0 (0%) Districts formation petition did not indicate a provision of public services.

Of the above **18** Districts, **18** (**100%**) Districts formation petition did indicate a provision of public services.

Of the above 18 Districts, 3 (17%) Districts did not begin or have not begun collecting revenue.

### **Revenues Collected:**

Of the **87** Districts required to submit an annual report for FY 23, **81** (**93%**) Districts state the revenues collected by the District during the fiscal year.

Of the **87** Districts required to submit an annual report for FY 23, **81** (**93%**) Districts state the expenditures made by the District during the fiscal year.

- 2 (2%) Districts did not specify the type of expenditures.
- 13 (15%) Districts did not incur any expenses.

Of the above 13 Districts, 2 (15%) projected no expenses in their FY 23 budget.

**6** (7%) Districts have no record of submitting an annual report.

# Detailed breakdown of public infrastructure, exterior, interior, and other improvements:

Of the **87** Districts required to submit an annual report for FY 23, **65** (**75%**) Districts provided a detailed breakdown of expenditures made by the District during the fiscal year.

- 10 (12%) Districts did not provide a complete line-item budget.
- 13 (15%) Districts did not incur any expenses.

Of the above 13 Districts, 2 (15%) projected no expenses in their FY 23 budget.

- 47 (54%) Districts claimed to incur expenses that are not reflected in the FY 23 budget.
- **6** (7%) Districts have no record of submitting an annual report.

Additional Info- Already Captured Above

13 (15%) Districts claimed that all improvements were complete before the reporting requirements and adoption of Ordinance 210565.

Of the **87** Districts required to submit an annual report for FY 23 and a proposed budget for FY 24, **79** (**91%**) Districts included the date they adopted their annual budget for FY 24.

- 3 (3%) Districts included the date they adopted their annual budget for FY 23.

Of the above 1 District, 1 (100%) District did not adopt an annual budget.

**6** (7%) Districts have no record of submitting an annual report.
