63273	James A. Reed Road, west side, from Bannister Road to Overhill Road	No Parking Anytime
63274	McGee Street, east side, from a point 212 feet north of Pershing Road north to 22nd Street	No Parking Anytime

Prohibition of <u>Parking</u> for longer than the <u>Time Limit</u>, as indicated below and as listed in <u>Section 70-531</u> is hereby discontinued at the following location(s):

Reserved Parking for <u>Physically Disabled Persons</u>, as indicated below and as listed in <u>Sections 70-534 and 70-535</u> is hereby discontinued at the following location(s):

63276	Charlotte Street, east side, from a point 315 feet south of 41st Street then south 25 feet	Handicapped Parking

63277	Cypress Avenue, east side, from a point 185 feet south of 27th Street then south 25 feet	Handicapped Parking
63278	North Oakley Avenue, west side, from a point 158 feet south of Scarritt Avenue then south 27 feet	Handicapped Parking
63279	Walrond Avenue, east side, from a point 145 feet south of 74th Street then south 25 feet	Handicapped Parking
