TO WHOM IT MAY CONCERN:

Pursuant to the authority granted in paragraph (b) of Section 70-38 of the "Code of General Ordinances of Kansas City, Missouri" and subject to the provisions thereof, traffic regulations are hereby made and adopted as follows:

The "**Through Street(s)**", as indicated below and as listed in **Section 70.335** is hereby discontinued at the following location(s):

The **Maximum Speed Limit**, as indicated below and as listed in **Section 70-363** is hereby discontinued at the following location(s):

63270	22nd Street, from The Paseo to Benton Boulevard	Thirty Miles Per Hour

Prohibition of **Stopping, Standing and/or Parking**, as indicated below and as listed in **Section 70-530** is hereby discontinued at the following location(s):

63271	11th Street, south side, from a point 170 feet east of Wyandotte Street to Baltimore Avenue	No Parking 7:00 AM to 6:00 PM Monday through Friday
63272	11th Street, south side, from a point 19 feet west of Baltimore Avenue then west 132 feet	No Parking 4:00 PM to 6:00 PM Monday through Friday
63273	James A. Reed Road, west side, from Bannister Road to Overhill Road	No Parking Anytime
63274	McGee Street, east side, from a point 212 feet north of Pershing Road north to 22nd Street	No Parking Anytime

Prohibition of **Parking** for longer than the **Time Limit**, as indicated below and as listed in **Section 70-531** is hereby discontinued at the following location(s):

63275	11th Street, south side, from a point 19 feet west of Baltimore Avenue then west 132 feet	Thirty Minute Parking 7:00 AM to 4:00 PM Monday through Friday

Reserved Parking for **Physically Disabled Persons**, as indicated below and as listed in **Sections 70-534 and 70-535** is hereby discontinued at the following location(s):

63276	Charlotte Street, east side, from a point 315 feet south of 41st Street then south 25 feet	Handicapped Parking

63277	Cypress Avenue, east side, from a point 185 feet south of 27th Street then south 25 feet	Handicapped Parking
63278	North Oakley Avenue, west side, from a point 158 feet south of Scarritt Avenue then south 27 feet	Handicapped Parking
63279	Walrond Avenue, east side, from a point 145 feet south of 74th Street then south 25 feet	Handicapped Parking
