Essential Families is committed to closing the digital divide and advancing opportunity in Kansas City. In the past 14 months, our services have empowered **665** individuals and families by providing reliable digital devices, affordable high-speed internet, and personalized digital literacy training. These supports have allowed our clients to pursue remote education, connect to health resources, and access meaningful employment—laying the foundation for lasting economic stability.

Despite this progress, the urgent need continues: our current waitlist stands at **1,604** families. This reflects ongoing disparities in access and demonstrates the critical trust and demand for Essential Families' innovative programs. Our goal is to scale these results and ensure every local family can fully participate in today's digital world.

Building Capacity & Creating Opportunity

With the rehabilitation of the Essential Families Office Building and the Francine Marie Kerr Family Center, this project will significantly boost community stability and job creation along the CCED corridor. The construction and operational phases will generate new, sustainable workforce opportunities, including:

- **47 Digital Case Managers (Digital Navigators)** to directly support families in acquiring and using technology for education, employment, and daily life.
- **6 Mental Health Clinicians** to offer on-site access to vital behavioral health services.
