Over the years, Bogotá has found great importance in cultural exchange and collaboration with fellow Creative Cities and benefits greatly form working in network. In particular, our collaboration with Kansas City through Jacob Wagner and Anita Dixon has been especially meaningful as we have found initiatives that connect musicians, cultural managers, and institutions across borders help enrich artistic practice and strengthen our capacities to manage culture and produce better policies for our creative forces.

Kansas City's history of musical innovation and its leadership within the global music community make adopting the Strategy especially important, as a city policy will send a clear message that culture matters in municipal decision-making and that investment in the arts is an investment in civic resilience and shared prosperity.

For these reasons, and with full respect for Kansas City's local process, we encourage the City Council to adopt Ordinance #250797. Doing so will affirm the city's role as a global cultural partner, protect and amplify the livelihoods of musicians, and create durable pathways for cultural exchange between our cities and across the UNESCO Creative Cities Network.

Bogotá looks forward to deepening our collaboration with Kansas City in the months and years ahead, and we stand ready to support joint programs, exchanges, and technical dialogue that strengthen the music ecosystems of both cities.
