# **Executive Summary**

Approving the petition to establish the Crossroads Community Improvement District; establishing the Crossroads Community Improvement District generally bounded by Truman Road to the north; Troost Avenue to the east; Kansas City Terminal Railroad to the south; and Broadway Boulevard to the west in Kansas City, Jackson County, Missouri; requiring the annual submission of certain records; and directing the City Clerk to report the creation of the District to the Missouri Department of Economic Development and the Missouri State Auditor.

# Discussion

This ordinance would approve the petition to establish the Crossroads CID for a 10year term, unless extended. This CID is composed of 779 parcels with 358 per capita owners. 51.4% of property owners within the boundaries signed the petition. Of those who signed, they own 51.94% of the assessed property value. These percentages both meet the minimum thresholds of greater than 50% which is required by state statute.

The District would have the authority to impose a 1% sales tax. The District would have authority to levy special assessments. The assessment amounts differ based on the size and use of the property (see petition for specific breakdown). The CID is proposing the following improvements and services: enhanced and additional landscape and streetscape, ongoing landscape maintenance and service, graffiti removal, trash and waste management, First Friday event management, and security.
