## REGULATION NUMBERS 66594 THROUGH 66602 REMOVALS

## TO WHOM IT MAY CONCERN:

Pursuant to the authority granted in paragraph (b) of Section 70-38 of the "Code of General Ordinances of Kansas City, Missouri" and subject to the provisions thereof, traffic regulations are hereby made and adopted as follows:

**<u>Stopping</u>** of all vehicular traffic as listed in <u>Section 70-335</u> is hereby discontinued at the following location(s):

66597	63rd Street, north side, from Brookside Boulevard to Brookside Plaza	No Parking Anytime

Prohibition of **<u>Parking</u>** for longer than the <u>**Time Limit**</u>, as indicated below and as listed in <u>Section 70-531</u> and <u>70-591</u> is hereby discontinued at the following location(s):

66599	8th Street, north side, from a point 131 feet west of Cherry Street to a point 30 feet east of Locust Street	Two Hour Parking 7:00 AM to 6:00 PM Monday through Friday
66600	63rd Street, south side, from a point 70 feet east of Baltimore Avenue to a point 40 feet west of Main Street	Two Hour Parking Only

The **Loading Zone** as indicated below and as listed in **Section 70-561** is hereby discontinued at the following location(s):
