RESOLUTION NO. TMP-4505

Love is retiring as a Maintenance Mechanic in the Facility Maintenance Division of the Convention and Entertainment Facilities Department at the City if Kansas City, after serving with dignity as Local No. 500 of The American Federation of State, County and Municipal Employees (AFSCME), AFL-CIO, Departmental Union Steward, where he represented bargaining unit employees throughout his years of service; and

PROCEDURE TO SUSPEND RULES, INTRODUCE A RESOLUTION & ADOPT THE RESOLUTION

COUNCILMAN O'NEILL:
