COMMITTEE SUBSTITUTE FOR ORDINANCE NO. 250297

Authorizing a construction contract with Radmacher Brothers Excavating Co. in the amount of \$15,391,961.95 for the Grand Boulevard Bridge Bike/Pedestrian Accommodations Project; and recognizing this ordinance as having an accelerated effective date.

WHEREAS, Ordinance 241044 reallocated bond funds to support the Grand Avenue Bridge Bike/Pedestrian Accommodations project to ensure the necessary funding is available; and

WHEREAS, the proposed construction will include a new pedestrian bridge, concrete sidewalk pavement, pedestrian lighting, drainage structures; NOW, THEREFORE

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the Director of the Public Works Department is authorized to execute a \$15,391,961.95 contract with Radmacher Brothers Excavating Co. for the Grand Boulevard Bridge Bike/Pedestrian Accommodations Project from funds previously appropriated to the following accounts. A copy of the contract is on file in the Public Works Department.


