

ORDINANCE NO. 120454

Authorizing the Director of Neighborhood and Housing Services to accept and enter into grant agreements with the U.S. Department of Housing and Urban Development ("HUD") for the 2011 Supportive Housing Program and to enter into contracts with various nonprofit subrecipients for delivery of services to homeless families and individuals in the Kansas City, Missouri area; and estimating additional revenues and appropriations in the amount of \$5,411.00 in the General Fund.

WHEREAS, the HUD approved Supportive Housing Program grant funding for the City of Kansas City, Missouri ("City") to provide for rental assistance for scattered site transitional housing, employment assistance, scattered site permanent housing, employment assistance services, prescription medication assistance, and housing counseling services; and

WHEREAS, this ordinance gives authorization to the Director of Neighborhood and Housing Services to accept and execute grant agreements with HUD for the 2011 Supportive Housing Program Grants in the amount of \$715,852.00; and

WHEREAS, in order to execute the terms of the agreements with HUD, the City of Kansas City, Missouri must enter into contracts with the designated non-profit subrecipient agencies represented in the City's application for 2011 Continuum of Care funding; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the Director of Neighborhood and Housing Services is authorized to enter into grant agreements with the U.S. Department of Housing and Urban Development for the 2011 Supportive Housing Program grant for the provision of homeless services and permanent housing for homeless families and individuals.

Section 2. That the revenue estimate in the following account of the General Fund is increased in the following amount:

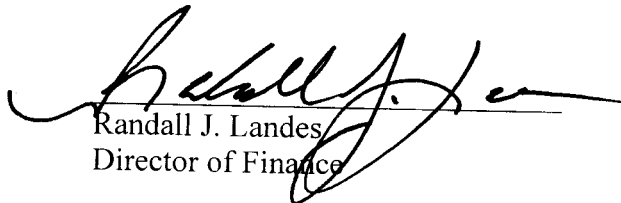

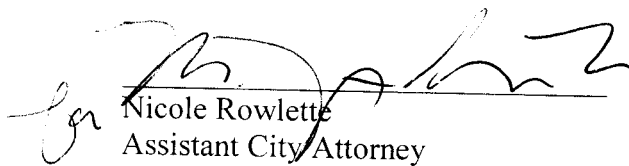

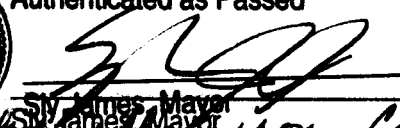
