ORDINANCE NO. 210432

Authorizing the City Manager to execute a contract to provide hotel, motel and other livable spaces arrangements for unhoused persons in Kansas City; designating requisitioning authority; appropriating \$1,800,000.00 from the unappropriated fund balance of the General Fund; and recognizing this ordinance as having an accelerated effective date.

WHEREAS, the Center for Disease Control and Prevention defines homelessness as a public health issue; and

WHEREAS, Kansas City is the hometown to as many as 1700 people in the houseless community, according to Project Homeless Connect Kansas City, with 370 people under the age of 18; and

WHEREAS, the COVID-19 pandemic exacerbated the public health issue by exponentially increasing job loss and financial struggle, particularly in communities of color and for those living at or near the poverty threshold as established by the United States' Department of Health and Human Services; and

WHEREAS, the intersecting and sometimes competing costs of housing and health create an undue burden on our city's poorest and most vulnerable residents; and

WHEREAS, the reduction of travel caused by the COVID-19 pandemic resulted in an influx of available hotel rooms in the city; and

WHEREAS, the City Council has expressed concerns over the living conditions for persons experiencing homelessness in Kansas City; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the City Manager is authorized to execute a \$1,800,000.00 contract to provide hotel, motel and other livable spaces arrangements for unhoused persons in Kansas City from funds hereby appropriated from the Unappropriated Fund Balance of the General Fund to the following account: 22-1000-572037-B-619080 Shelter for the Homeless \$1,800,000.00

Section 2. That the Director of Neighborhoods and Housing Services is designated as requisitioning authority for Account No. 22-1000-572037.

Section 3. That the City Manager is hereby authorized to enter into contracts to implement this ordinance.

Section 4. That this ordinance, appropriating money, is recognized as an ordinance with an accelerated effective date as provided by Section 503(a)(3)(C) of the City Charter and shall take effect in accordance with Section 503 of the City Charter.
