To City of Kansas City, City Clerk:

The Wagon Trails CID provides “clean and safe” services along sections of Westport Road, Belleview and Madison Streets in Midtown Kansas City. We employ Area Maintenance Attendants and Area Awareness Officers through our subcontractors to complete these community services. We also utilize Midtown KC Now to help engage the community and work closely with all the stakeholders in the area.

Attached you will find the adopted forecasted budget for the Wagon Trails Community Improvement District (CID), a political subdivision, fiscal year May 1, 2025 – April 30, 2026 along with the current Board of Directors and Financial Statement of year May 1, 2024 – April 30, 2025. The proposed Annual Budget for 2025-26 was submitted to the City Clerk on January 24, 2025. The Annual Budget for Fiscal Year 2025-26 was adopted on March 12, 2025. The Annual Report was submitted for Fiscal Year 2023-24 on July 23, 2024.

The Wagon Trails CID is funded by a ½ percent (1/2%) sales tax and a one percent (1%) assessment on real property.

As you can see on the financial statements, no funds were used for interior improvement or exterior improvements. Additionally, no funds were spent on public infrastructure improvements, though the vast majority of expenses go for services in public space. That’s the nature of our “clean and safe” program.
