Housing and Community Development Department

250345 Sponsor: Director of Housing and Community Development Department

Accepting the recommendation of the Housing Trust Fund Advisory Board revising the affordability levels for the Taliaferro & Browne Prospect Summit Townhomes project; and authorizing the Manager of Procurement Services to execute a funding agreement amendment to reflect said change.

Mary Owens, Department of Housing and Community Development, presented. This ordinance approves the Housing Trust Fund Advisory Board's recommendation to approve a change in the affordability levels for the Prospect Summit Townhomes project. Initially awarded through Ordinance 230962 under Round III of the Housing Trust Fund, this project has established CREO goals of 15% MBE and 15% WBE for Construction Services, and 14% MBE and 14% WBE for Professional Services.

Authorizing the Chief Procurement Officer to execute contracts with area health centers to include Children's Mercy Hospital, Northland Health Care Access, Swope Parkway Health Center, Kansas City CARE Clinic, Samuel U. Rodgers Health Center, and University Health, to provide primary health care services to uninsured residents in Kansas City, Missouri; authorizing the Chief Procurement Officer to extend the term of the contracts or increase the total contract dollar amounts upon need and appropriation; and establishing an accelerated effective date.

Bill Snook, Health Department, presented. The ordinance authorizes the Chief Procurement Officer to execute contracts with six local health centers-Children's Mercy Hospital, Northland Health Care Access, Swope Parkway Health Center, Kansas City CARE Clinic, Samuel U. Rodgers Health Center, and University Health-to provide primary health care services to uninsured residents of Kansas City, Missouri. The Chief Procurement Officer is also authorized to extend the contract terms or increase the contract amounts as needed. This ordinance addresses the ongoing need for health care services among uninsured and underinsured citizens in Kansas City, ensuring that these essential services are funded and provided effectively. Accepting an additional \$10,685.00 for a 3-month extension from the Victims of Crime Act (VOCA) grant funded, by the U.S. Department of Justice, and passed through the State of Missouri's Department of Public Safety to support the work of the City's Prosecutor's Office; estimating and appropriating \$10,685.00 in the General Grants Fund; authorizing the City Attorney to enter into a subaward grant agreement in connection with this grant; and recognizing this ordinance as having an accelerated effective date.

It also authorizes the City Attorney to enter into a subaward grant agreement. This ordinance ensures the continued support and funding for essential services provided by the City's Prosecutor's Office to assist victims of crime.

Matthew Barnes, City Planning and Development, presented. This ordinance approves the rezoning of approximately 20 acres at the southwest corner of Northwest 68th Street and North Madison Avenue from District R-80 to District R-6, along with a development plan to create 57 residential lots and 5 tracts. The approval includes conditions related to tree preservation, landscaping, street trees, signage, fire safety, infrastructure improvements, and compliance with city codes. The developer must also ensure proper sight distance, repair sidewalks, and improve N. Holly Street to residential collector standards. This plan facilitates residential development while ensuring adherence to safety and regulatory requirements. A presentation is on file with the City Clerk's Office.
