A Resolution Approving the Annual Budget for Fiscal Year May 1, 2024 – April 30, 2025, for the Linwood Square Shopping Center Community Improvement District

WHEREAS, having provided notice of the meeting of the Board of Directors of the Linwood Square Shopping Center Community Improvement District ("District") in accordance with Section 610.020 of the Revised Statutes of Missouri, the Board of Directors met on the 16th day of November, 2023; and

WHEREAS, the Board of Directors desire to adopt the CID Annual Budget for the May 1, 2024 – April 30, 2025 Fiscal Year.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Directors of the Linwood Square Shopping Center Community Improvement District, as follows:

- 1. The District hereby adopts as its proposed budget and budget message for the fiscal year beginning May 1, 2024 and ending April 30, 2025, the budget and budget message which are attached hereto as **Exhibit A** and which are incorporated herein by this reference.
- 2. The District's staff is directed and authorized to submit the budget to the City Manager or designee.
- 3. The Board of Directors will consider any written comments received from the City Manager or designee pursuant to the Agreement.
- 4. Subject to the condition in Section 2 of this Resolution, the District hereby adopts as its budget for the fiscal year beginning May 1, 2024 and ending April 30, 2025, the budget which is attached here to as **Exhibit A** and which is incorporated herein by this reference. In the event the District receives written comments from the City which the District desires to adopt, the Board may amend the budget by further resolution.
- 5. This resolution shall take effect immediately upon its execution.

BUDGET MESSAGE

The Linwood Square Shopping Center Community Improvement District ("District") was declared established by Ordinance No.191023 of the City Council of the City of Kansas City, Missouri on December 12, 2019. The District desires to fund, or assist in the funding of, certain services and improvements as allowed by Sections 67.1401 to 67.1571 RSMo.

On May 28, 2020, the District's Board of Directors passed Resolution No. 2020-07 which imposed, upon approval of the qualified voters of the District, a one percent (1%) sales and use tax on retail sales in the District for the life of the district. The sales and use tax collection became effective on January 1, 2022.

The District has adopted a fiscal year beginning May 1 and ending April 30 of each year.

One December 8, 2021 the District's Board of Directors passed Resolution No. 2021-06 which authorized the execution of a reimbursement agreement with Linwood Shopping Center Redevelopment Company LLC. There have been no reimbursements or costs certified at this time.
