

ORDINANCE NO. 180480

Amending Chapter 70, Code of Ordinances, by repealing Section 70-524, Manner of parking generally, and enacting in lieu thereof a new section of like number and subject matter related to the maximum distance vehicles may park from the curb in locations with bike lanes.

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That Chapter 70, Code of Ordinances, is hereby amended by repealing Section 70-524, Manner of parking generally, and enacting in lieu thereof new sections of like numbers and subject matters related to the maximum distance vehicles may park from the curb in locations with bike lanes, to read as follows:

Sec. 70-524. Manner of parking generally.

(a) Two-way roadways. Except as otherwise provided in this chapter, every vehicle stopped or parked upon a two-way roadway shall be so stopped or parked with the right hand wheels parallel to and within 12 inches of the right hand curb or as close as practicable to the edge of the right hand shoulder. A vehicle bearing and properly displaying a valid license plate or placard issued pursuant to RSMo § 301.071 or 301.142, or a valid equivalent license plate or placard issued by the state, country or other place of which such vehicle's owner is a resident, may stop or park upon a two-way roadway in a residential parking area as defined in section 70-1 with the left hand wheels parallel to and within 12 inches of the left hand curb or as close as practicable to the edge of the left hand shoulder.

(b) One-way roadways. Except as otherwise provided in this chapter, every vehicle stopped or parked upon a one-way roadway shall be so stopped or parked in the direction of authorized traffic movement with the right hand wheels parallel to and within 12 inches of the right hand curb or as close as practicable to the edge of the right hand shoulder, or with the left hand wheels parallel to and within 12 inches of the left hand curb or as close as practicable to the edge of the left hand shoulder.

(c) Streetcar line roadways. Where parking is allowed along a streetcar service line, vehicles parked along the curb in a marked parking space shall not be allowed to cross or encroach any part of the vehicle over or onto the pavement surface marking that defines the parking space.

(d) Striped bike lanes. Where a striped bike lane is present between permitted parking and the right hand (or left hand) curb or shoulder, every vehicle stopped or parked shall be so stopped or parked with the right hand (or left hand) wheels parallel to and within 12 inches of the edge of the striped parking line adjacent to the bike facility.

(e) Violation. Any person violating any provision of this section shall be punished by a fine of not less than \$25.00.

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That Chapter 2, Code of Ordinances of the City of Kansas City, Missouri, is hereby amended by repealing Section 2-115 relating to open meetings and records pursuant to the Sunshine Law and enacting in lieu thereof one new section of like number and subject, to read as follows:

Sec. 2-115. Open meetings and records.

~~(a)~~ ~~(a)~~ *Terms to have same meanings as in Missouri Sunshine Law.* For purposes of this section, the terms "closed record," "public record," and "public governmental body" shall have the same meaning as defined in the Missouri Sunshine Law, ~~RSMo ch. Chapter~~ 610. ~~RSMo~~

~~(b)~~ ~~(b)~~ *Policy.* It is the policy of the city that the city's public records, and the meetings, votes, actions and deliberations of the city's public governmental bodies, are open to the public unless otherwise provided by law. All public records authorized to be closed under the Missouri Sunshine Law or any other law are closed records. Meetings, votes, actions and deliberations of the city's public governmental bodies may be closed as authorized under the Missouri Sunshine Law or any other law.

~~(c)~~ ~~(c)~~ *Public meetings.* Unless otherwise approved by the city manager or mayor, in compliance with Missouri Sunshine Law requirements, all public governmental bodies shall give at least 24 hours' notice (exclusive of weekends and holidays) of the time, date and place of each meeting, and its tentative agenda. All notices must be submitted to the city clerk's office as soon as feasible but not later than 24 hours prior to the meeting. The city clerk will give the notice required.

~~(d)~~ ~~(d)~~ *City communications director to be custodian of records.* The ~~city communications director~~ ~~City Records Request Commissioner~~ shall be the sole custodian of the public records of the city, including all of its departments, offices, boards, commissions, committees, and other public governmental bodies of the city. ~~The city communications director~~ ~~The City Records Request Commissioner~~ is not the custodian of records for any other political subdivision of the state or any separate corporation.
