Directing the City Manager to issue a traffic control permit for St. Paul's Episcopal Day School for the closure of Walnut Street between East 40th Street and East 41st Street during school hours; and directing the City Manager to approve any permits related to traffic calming projects by St. Paul's along the same road.

CM Crispin Rea, City Council, presented. This ordinance is a committee sub to close a street during business hours and provide permits for traffic calming efforts. CM Rea stated that representatives from the school, neighborhood, and city collaborated by canvassing and walking around the affected area. Together, they developed a proposal to support both the school and nearby residents. The Council emphasized that the ordinance language should apply specifically to the permit request for traffic calming and the temporary street closure during business hours (9:00 a.m. to 3:00 p.m.). The matter will be revisited after the conclusion of summer school. There was Public Testimony filed.

Authorizing Amendment No. 1 in the amount of \$469,914.00 to a design professional services agreement with Kimley-Horn and Associates, Inc. for the Northeast 52nd Street Improvements - North Randolph to North Wheeling Avenue project for a total contract amount not to exceed \$609,914.00; and recognizing this ordinance as having an accelerated effective date.

Nicolas Bosonetto, Public Works Department, presented. This ordinance authorizes the installation of sidewalks to improve pedestrian safety, particularly for school-age children walking to the nearby elementary and middle schools. The project is expected to be completed by late 2026. CW Lindsay French noted that this area is considered a dangerous route. A representative from Kimley-Horn was present. Appropriating \$8,984,008.12 from the Unappropriated Fund Balance of the Capital Improvements Fund to the Northeast Vivion Road - Streetscape Improvements project; and recognizing this ordinance as having an accelerated effective date.

Sponsors: Director of Public Works, French and Rea

Nicolas Bosonetto, Public Works Department, presented. This ordinance establishes a joint project between MoDOT and the City of Kansas City to complete streetscape improvements along Northeast Vivion Road. The project includes sidewalks and pedestrian pathways to improve access to local schools. It includes \$430,000 in GOP funds and does not impact the five-year CIP. Additional funding will come from MoDOT, federal sources, and Clay County. There is currently a \$300,000 funding gap, and Public Works will seek additional federal CMAQ funds to cover it. Amending Chapter 70, Article XII of the Code of Ordinances, entitled "Traffic Control Signs, Signals, and Devices," by amending Sections 70-954 of the Code of Ordinances to prohibit right turns in school zones when school zone speed limits are in effect.

Katherine Nace, Mayors Office and Jason Waldron, Public Works, presented. This ordinance is a committee sub that will install new signage prohibiting right turns, when traffic light is red in designated school areas. Signs will be installed where deemed necessary. Schools that believe the restriction would negatively impact traffic flow or student pickup must submit a waiver explaining their concerns. CW Melissa Robinson emphasized the importance of public engagement between schools and neighborhood residents to ensure awareness and input.
