



 - The Company has been advised the land has been re-platted however our search did not develop new plat to appear on the record. However, we find the above ordinance is in relation to the proposed plat.
- 58. Consequences, if any, for loss or damage occasioned by the lack of a right of access to and from the surface for the subsurface parcel.

It is our understanding that all quarry, rock, extraction and or other working leases have expired or otherwise been terminated and that there are no active quarrying operations being conducted at this location. Further, that the ownership of all rock, rock materials, stone, timber and the spaces of the underground quarry are in single ownership of the entity shown as vested on Schedule A above. Additionally, that no crops have been grown, are

growing or to be grown on the land. Also, that there are no Profits a Pendre, or none that have not been terminated and extinguished. In this regard and as a requirement to remove such items from the Schedule B exceptions the Company must be furnished with an affidavit, in recordable form, to be recorded at the discretion of the Company, made by a reliable person well acquainted with the facts, avering as to the non-existence of such issues/items, as well as the continuous, open, exclusive and peaceable possession of the lands in question during the last past 15 years.

- 59. Consequences, if any, arising from subsidence. The presence and location of improvements and facilities for an underground quarry including quarry adits/portals/entrances and air shafts whether open or blocked.
- 60. Rights of the surface and adjacent land owners to lateral and subjacent support.
 - Consequences, if any, arising from the lack of distinct and separate tax assessments for the land and or for the estate, interest, spaces thereof or leases if any as to any subsurface area.
- Railroad rights-of-way, switch tracks, spur tracks, and all easements, licenses or servitudes within, appurtenant to or serving such rights-of-way or easements, including, but not limited to, electric and telephone transmission lines, broadband transmission lines, video and multi-channel video, pipelines and any facilities in support of telephony, communication or transportation.
- 62. Tenancy rights, either as month to month or by virtue of written leases, of persons now in possession of any part of the Land.
- Any documents being executed in conjunction with this transaction must be signed in the presence of an authorized Company employee, an authorized employee of an agent, an authorized employee of the insured lender, or by using Bancserv or other approved third-party service. If the above requirement cannot be met, please contact your closer. - 68. In all respects, the Company reserves the right to make such further exceptions and or requirements it deems necessary.
- The actual value of the estate or interest to be insured must be disclosed to the Company, and subject to approval by the Company, entered as the amount of the Policy to be issued. It is agreed that, as between the Company, the applicant for this commitment, and every person relying on this Commitment, the amount of the requested Policy will be assumed to be \$2500.00, and the total liability of the Company on account of this Commitment shall not exceed that amount, until such time as the actual amount of the Policy to be issued shall have been agreed upon and entered as aforesaid, and the Company's applicable charges for same shall have been paid.
