| <p>Reason for Legislation Accepting and approving a \$98,623.13 grant from the Missouri Department of Health and Senior Services that implements the Summer Feeding Service Program through the Kansas City Parks and Recreation Department; and appropriating that amount to the Parks and Recreation Department for fiscal year 2015-2016.</p> <p>Discussion The Kansas City Parks and Recreation Department has been approved to become a sponsoring agency for the Missouri Department of Health and Senior Services Summer Feeding Service Program. The program reimburses sponsoring organizations, on a per meal basis, for providing healthy nutritious meals during summer hours.</p> <p>The City has been approved for up to \$98,623.13 worth of eligible meals.
