

ORDINANCE NO. 160514

Authorizing a Cooperative Agreement with Platte County, Missouri for County construction projects on City roadways and directing the City Clerk to file the Agreement in Platte County, Missouri.

WHEREAS, on April 8, 2003, the voters of Platte County approved a county wide sales tax ("the Tax") for 10 years for the purpose of financing transportation related projects, including, but not limited to, roads, bridges, drainage structures and sidewalks; and

WHEREAS, Ordinance 041197, approved on November 4, 2004, authorized the execution of a Cooperative Agreement with Platte County, Missouri for County construction projects on City roadways; and

WHEREAS, the County used the Tax to improve Green Hills Road between Route 152 and Barry Road, North Congress adjacent to the Park Hill High and Congress Middle Schools, Barry Road from Amity to Chariton, North Congress between I-29 and Route 152, and most importantly improving the Barry Road and I-29 interchange; and

WHEREAS, due to the successful completion of these projects, on April 2, 2013, the voters of Platte County renewed the Tax for 10 years for the purpose of financing transportation-related projects, including but not limited to roads, bridges, drainage structures, and sidewalks; and

WHEREAS, the County and City are now partnering to fund improvements on N Northwood Road from N Prairie View to 52nd Street, Green Hills Road between Barry Road and NW Platte Brooke Drive, NW 72nd Street from Roanridge Road to Overland Drive, Waukomis Drive between Englewood Road and NW 62nd Street and continuing to 68th Street, and street lights along NW Barry Road between N Potomac and N Chariton; and

WHEREAS, due to the partnership between the County and City, the Tax has been leveraged with \$10,000,000 of federal surface transportation funds for improvements for NW 72nd Street and Waukomis Drive; NOW, THEREFORE,


ORDINANCE NO. 160514

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the Director of Public Works is hereby authorized to enter into a Cooperative Agreement with Platte County for the funding and construction of various transportation related improvements to City roadways, all located within Platte County, Kansas City, Missouri, Council District 2. The Cooperative Agreement is approved in substantial form as that on file in the office of the Director of Public Works.

Section 2. That upon the effective date of the Cooperative Agreement, the City Clerk is directed to cause a copy of this ordinance and of the Agreement to be recorded in the office of the Recorder of Deeds of Platte County, Missouri.
