### Executive Summary

Approving the 2026 Action Plan for the Community Development Block Grant (CDBG), HOME Investment Partnership Program (HOME), the Emergency Solution Grant (ESG), and Housing Opportunities for Persons with AIDS (HOPWA); and reprogramming funds from CDBG in the amount of \$2,470,098.59; and HOME in the amount of \$4,337,410.37; and authorizing submittal to United States Urban Development for its consideration.

### Discussion

Several City programs and services rely on grant funding from the US Department of Housing and Urban Development: CDBG provides public services, public facilities and improvements, minor home repair, elimination of blight and land acquisition; HOME provides housing renovation and finances for the City's housing development projects for the benefit of low- to moderate- income persons; and HOPWA provides assistance to persons with AIDS; Emergency Solutions funds shelter operations and essential services. To continue to fund these services, the City must submit their Action Plan to HUD. This legislation certifies that the 2026 Action Plan has been prepared and will be submitted to the US Department of Housing and Urban Development for consideration.
