## **Executive Summary**

Authorizing a \$199,471,19 construction contract Change Order No. 1 to Contract No. 9826-1 with Leath & Sons, Inc., for the Water Main Replacement - Subsidiary Replacements Renewal No. 1 project for a total contract amount of \$699,471.19; and recognizing this ordinance as having an accelerated effective date.

### **Discussion**

### **Project Justification**

The Water Services Department is undertaking this construction project to improve distribution system reliability, increase hydraulic conveyance capacity, and support fire protection to replace aging, break-prone cast iron pipe (CIP) water mains with ductile iron pipe (DIP).

This project provides cost savings to the City by replacing the entire block vs. repairing small sections at a time.

### Project Description/Executed Construction Contract Summary

Work on this construction project will cover unforeseen added street blocks of water mains to be replaced that are outside of the scope of Engineering projects already executed.

The City executed the original construction contract totaling \$500,000.00 under Contract No. 9826 on February 23, 2024.

The City executed the Renewal No. 1 construction contract totaling \$500,000.00 under Contract No. 9826-1 on September 27, 2024.

This proposed ordinance for a \$199,471.19 Change Order No. 1 is needed to replace unforeseen added street blocks of water mains to be replaced outside of the scope of Engineering projects already executed.

In addition, an ordinance is needed for this Change Order No. 1 due to the dollar amount exceeding City Council authorization when totaling the original contract and renewal contracts together.

#### Term

The term of the construction project is 365 calendar days.

#### MBE/WBE Goals

CREO KC established goals of 11% MBE and 11% WBE on this construction project on May 26, 2023 as part of the Annual Goal Program.

#### Solicitation

The construction project was originally advertised in accordance with the City's requirements. Public bids were opened for the construction project on December 5, 2023 with 6 bidders responding.

### <u>Awardee/Subcontracting Participation</u>

Leath & Sons, Inc. was originally selected for this project as the lowest, most responsive, and most responsible bidder with a contract amount of \$439,748.68, with subcontracting participation of 11% MBE and 11% WBE. This contract was based on unit prices with a maximum expenditure of \$500,000.00.
