Authorizing a \$500,000.00 construction contract with SHEDIGS IT, LLC, for the Valve Straightening and Water Distribution System Repairs, Renewal No. 2 project; and recognizing this ordinance as having an accelerated effective date.

Jeff Martin, Water Services Department, presented. This ordinance authorizes a construction contract with SHEDIGS IT, LLC. for valve straightening and distribution system repairs. This contract consists of straightening misaligned valve boxes as well as performing other water distribution system repairs on an as-needed basis. This contract is based on unit prices for the cumulative of the original contract, Renewal No. 1 and this ordinance's Renewal No. 2. Work will be performed throughout Kansas City, in Cass, Clay, Jackson, and Platte Counties. Goals for the project have been set and completed. This is the final renewal for the project.

The potential streets have been vetted by staff using criteria including but not limited to the scheduled resurfacing program, streets that are four or more undivided lanes, and corridors identified as part of a high-injury network.
