Shall the City of Kansas City, Missouri issue and sell waterworks revenue bonds in the principal amount of \$500,000,000.00 for the purpose of extending and improving the waterworks system of the City including, but not limited to (1) the continued expansion of the water distribution system, (2) replacement of water mains, (3) rehabilitation and expansion of water treatment plants, pump stations, and other water facility improvements, (4) ensuring a reliable water supply to include intake modifications and/or supplemental ground water supplies, and (5) protecting and safeguarding the waterworks system, with the principal and interest of said bonds to be payable solely from

the revenues derived by the City from the operation of its waterworks system, including all future improvements and expansions thereto?

and it was found and determined that more than a simple majority of the qualified electors of the City voting on the question had voted in favor of the issuance of said revenue bonds for the purpose aforesaid, the vote on said question having been 20,330 votes for the question to 5,275 votes against the question; and

WHEREAS, the City has previously issued \$339,390,000.00 of water revenue bonds authorized pursuant to the 2014 Election leaving \$160,610,000.00 of the water revenue bonds authorized pursuant to the 2014 Election unissued and the City proposes to issue additional water revenue bonds (the "Series 2025A Bonds") in Spring 2025 to fund \$153,900,000.00 in project costs, costs of issuing the bonds, and credit enhancements, if necessary; and

WHEREAS, the planned projects to be funded from the Series 2025A Bonds are outlined on Attachment A to this ordinance which advance appropriates the bond proceeds in order to begin work on the projects as soon as possible; and

WHEREAS, the issuance of the bonds will be authorized in a subsequent ordinance to come before the City Council for approval; NOW, THEREFORE,

#### BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That Fund No. 8082 is hereby established as the Water Revenue Bond Series 2025A Project Fund in the records of the City of Kansas City, Missouri.

Section 5. That the City Council hereby declares its official intent to reimburse itself for certain expenditures made within sixty (60) days prior to or on and after the date of this Ordinance with respect to appropriations in Section 3 (the

That the Director of Finance is hereby authorized to close project accounts, encumbrances and retainage related to the accounts in Section 3 and return the unspent portion to the fund balance from which it came upon the earliest of: (i) Project's completion; (ii) final maturity of financing, or (iii) five years after issuance.

Section 7. That this Ordinance is recognized as an ordinance with an accelerated effective date as provided by Section 503(a)(3)(C) of the City Charter in that it appropriates money and shall take effect in accordance with that section.

### **Discussion**

The voters of Kansas Ciy authorized the issuance of \$500 million in water revenue bonds for extensions and improvements to the City's waterworks system. # **Executive Summary**

Authorizing a \$6,885,000.00 Design-Build Contract with Kissick Construction Company, Inc., for Renewal No. 3 for the City-Wide Sewer Infrastructure Rehabilitation within Waterways Project.

#### **Discussion**

#### Reason for Contract

In 2010, the City of Kansas City, Missouri entered into a Consent Decree with the United States Environmental Protection Agency (EPA) to reduce the volume and frequency of overflows from the City's sewer system. The City's Smart Sewer Program is currently in year 14 of a 30-year implementation period.

The purpose of this project is to rehabilitate existing sewer infrastructure that is damaged or exposed due to the asset's age and proximity to nearby eroding, migrating, or incising waterways. Damaged and exposed sewer segments located near waterways are at risk of receiving large amounts of inflow and infiltration when exposed to creek flows and stream migration. Investigating and rehabilitating these assets will help to reduce large sources of inflow and infiltration to the City's sewer system and prevent overflows and exfiltration of wastewater to the natural environment.

# Construction Contract Description

The scope of work to be provided under this Design-Build contract will provide design-build services to investigate, design, and construct approximately twelve (12) already identified rehabilitation sites located around the City, totaling up to 5,120 linear feet of sanitary sewer infrastructure.

The term of this project will be 730 calendar days.

#### Solicitation

City-Wide Sewer Infrastructure Rehabilitation within Waterway Project was advertised in accordance with the City's requirements. The Technical Approach and Price Submittals were submitted on November 15, 2016, with five (5) proposers/bidders responding. Public bids were opened on November 29, 2016.

The original Contract No. 1275 was advertised to allow for 3 successive renewals, with each renewal subject to further City Council approval.

#### <u>Awardee/Subcontracting Participation</u>

The team of Pyramid Excavation & Construction, Inc. and Wilson & Company was the apparent lowest, responsible, and responsive bid based on technical and price submittal. After the bids were read, Pyramid/Wilson withdrew their bid because they found a substantial calculation error in their bid and the Designer of Record resigned from Wilson & Company.

The second highest score based on the technical and price submittals is the team of Kissick Construction and CDM Smith. The bid documents, qualification, and financial information for Kissick Construction and CDM Smith was evaluated. After the evaluation, Kissick Construction and CDM Smith was recommended as the lowest,

responsible, and responsive bidder, with subcontracting participation of 11% MBE and 6% WBE.

#### Comments:

This is the second renewal of contract 1275. The first renewal was contract 1493. Contract 1275 was closed out with the prime contractor achieving 11% MBE and 8% WBE. Contract 1493 is still open and the prime contractor is currently achieving only 6% MBE and 0.2% WBE according to B2G. The prime contractor indicated that they still plan to meet the goals on the project with the dollars remaining in the contract. The prime contractor indicated that there are some payments which have not been entered in B2G which would increase their current participation and the prime contractor is working with CREO KC to get the payments updated. The prime contractor also indicated that there have been some projects under the contract which have been delayed by the Dept. and those projects will have significant MBE/WBE participation. The prime contractor also indicated that there has been over \$1,700,000 in emergency repairs on the contract and over \$1,000,000 in CIPP work- and both the emergency repairs and the CIPP work have limited opportunities for MBE/WBE participation. Still, there is \$2,054,458.38 remaining on the contract and there will be opportunities for the prime contractor to meet the goals of 11% MBE and 6% on the contract. The prime contractor has already identified some of the areas where they will be able to obtain additional MBE/WBE participation on the work remaining on the contract.

The prime contractor also indicated that EJ & Sons Construction has not yet invoiced \$30,000 in work on the Barry Harbor project that will add dollars to the WBE participation. These additions would increase the participation achieved to date to 14% MBE and 3.7% WBE based on the current amount paid. The prime contractor indicated that design services on six (6) future sites would add \$240,000 for TREKK Design for WBE credit. Using the information above the prime's expected participation on the total contract amount would be as follows:

\$677,987.07 out of \$6,885,000 for 10% MBE \$418,120.55 out of \$6,885,000 for 6% WBE.

The prime contractor indicated that they intend to meet both the MBE and the WBE goal. The prime contractor indicated that they have been hampered by emergency work that was added to the contract totaling \$1,700,000 where there were limited opportunities for MBE/WBE participation and the fact that over \$1,000,000 of the work performed to date was for CIPP Lining work where there is no opportunity for MBE/WBE participation. The 2 sites that were on hold for over \$710,000 has also limited the opportunities for MBE/WBE participation, but those sites should be starting soon. There is still \$2,054,458.38 remaining on the contract so there will be additional opportunities for MBE/WBE participation.

## **Executive Summary**

Authorizing the Director of Water Services Department to accept a \$363,000.00 grant from the U.S. Environmental Protection Agency (EPA) to update the National Wetland Inventory for the City of Kansas City, Missouri; estimating and appropriating a total of \$363,000.00 in the Capital Grants Fund for this grant; authorizing the implementation of a grant award from the EPA; designating requisitioning authority; and authorizing the Director of the Water Services Department to act as the City's designated representative for participation in the EPA Wetland Program Development Grants in accordance with federal requirements administered by the EPA.

## **Discussion**

The City of Kansas City, Missouri filed an application with the EPA Wetland Program Development Grants (WPDGs) for an award provided by the EPA pursuant to Section 104(b)(3) of the Clean Water Act (CWA), 33 U.S.C. § 1254(b)(3).

Under the terms of section 104(b)(3) of the CWA, the EPA has authorized funds to authorized applicants to develop or refine wetland programs by conducting or promoting the coordination and acceleration of research, investigations, experiments, training, demonstrations, surveys, and studies relating to the causes, effects, extent, prevention, reduction, and elimination of pollution.

The EPA has selected the City to be awarded a Wetland Program Development Grant in the amount of \$363,000.00 to finance a scientific survey and inventory local wetlands and riparian forests; provide relevant public education and outreach for improving the existing policies and better management of stormwater, especially for economically distressed, historically underserved and disproportionately burdened communities in Kansas City; and improve existing policies and practices pertaining to the wetlands and riparian forests, where applicable.

This proposed ordinance will authorize the Director of Water Services Department to accept funding from the U.S. Environmental Protection Agency to update the National

Wetland Inventory for the City of Kansas City, Missouri, estimate and appropriate revenue funds, and authorize the implementation the grant award from the EPA.

In addition, this proposed ordinance will authorize the Director of the Water Services Department to act as the City's designated authorized representative for participation by the City, through its Water Services Department, in the EPA WPDGs in accordance with federal requirements administered by the EPA.
