

ORDINANCE NO. 150559

Authorizing a License Agreement with Selective Site Consultants, Inc., to install and maintain a wireless digital data communications; and estimating revenue in the amount of \$2,700.00 in the Pole Attachment Fees account.

WHEREAS, Selective Site Consultants, Inc., is a developer of infrastructure (small cells) used by wireless carriers to provide certain telecommunications services; and

WHEREAS, Selective Site Consultants, Inc., proposes to locate, place, attach, install, operate and maintain Selective Site Consultants, Inc., communications equipment on or within the City's right-of-way (a) on or within the City facilities in said areas, and (b) on or within the facilities (i.e. poles, lines, wires, and conduit) of other utility companies such as Kansas City Power and Light (KCP&L) and AT&T pursuant to Selective Site Consultants, Inc., separate locate agreements with said utility companies; and

WHEREAS, Selective Site Consultants, Inc., proposes to install and maintain Selective Site Consultants, Inc., attachments on or within City facilities to provide communications services; and

WHEREAS, the City is willing, to grant Selective Site Consultants, Inc., a non-exclusive, revocable license under which the City will issue permits authorizing Selective Site Consultants, Inc., to enter upon the City's right-of-way to locate, place, attach, install, operate, maintain, remove, reattach, reinstall, relocate and replace Selective Site Consultants, Inc., communications equipment attachments, and for the placement or installation of Selective Site Consultants, Inc., attachments on or within specified City facilities; and

WHEREAS, the City may in its sole discretion, for reasons relating to insufficient capacity, safety, reliability, generally applicable engineering purposes or other governmental needs, uses, obligations and reason, refuse to issue a permit for any particular City facility so long as Selective Site Consultants, Inc., is treated in a competitively neutral and non-discriminatory manner as compared with other similarly situated third parties; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:


Section 1. That the Director of Public Works is authorized to execute a License Agreement with Selective Site Consultants, Inc., to install and maintain a wireless digital data communications network using equipment attached to streetlight poles in the public right-of-way network for a term of eight years, with two possible additional terms of five years each thereafter. A copy of the License Agreement is on file in the office of the Director of Public Works.

Section 2. That the revenue in the following account is hereby estimated in the following amount:


