

Bids for the above referenced project were received and opened on September 10, 2024. Eight (8) bidders responded. The lowest and fully responsive bid was submitted by Infrastructure Solutions, LLC. in the amount of \$7,724,800.00 (\$7,574,800.00 with a \$150,000.00 allowance). The lowest bidder, Hettinger Excavating, LLC did not submit a complete 'Evidence of Competency to Perform' as required in Form 00210 Instructions to Bidders. Therefore, Hettinger Excavating is considered a non-responsive bidder.

Project Description

This project includes the replacement of approximately 12,995 LF of 16-inch break-prone CIP transmission water main with 16-inch DIP water along Prospect Avenue from East Linwood Boulevard to East 63rd Street, in Kansas City, Jackson County, Missouri.

MBE/WBE Participation

The Civil Rights and Equal Opportunity (CREO) Department set the MBE/WBE goals for this project at 11% MBE and 11% WBE business participation. Infrastructure Solutions submitted their Contractor Utilization Plan with 11% MBE and 11% WBE business participation. Infrastructure Solutions has no written violations of the City's MBE/WBE program.

Experience Reference Form

The project manager reviewed the Bid Form and Infrastructure Solutions has overall prices similar to the Engineer's Opinion of Probable Construction Cost, and are acceptable. Infrastructure Solutions submitted the required Evidence of Competency and Experience Reference Form/Summary for similar projects.

Claims and Lawsuits

Infrastructure Solutions has no open suits involving the company. There are no liens or other judgments against the company.

List of Subcontractors and Suppliers


Infrastructure Solutions submitted an acceptable List of Subcontractors to be used on this project and it is included in the Bid Packet.
