Executive Summary

Vacating an approximately 1,120 square foot section of right-of-way in District R-6 (Residential) generally located at 1804-1812 Mercier Street; and directing the City Clerk to record certain documents. (CD-ROW-2025-00006)

Discussion

The portion of public right-of-way requested to be vacated is approximately 1,120 square feet on the northwest side of Mercier Street along 1804 - 1812 Mercier Street. Ordinance No. 210838 approved a development plan to allow for the construction of five single-family homes. Those homes were constructed and following an inspection, it was found that each residential structure encroached in the public right-of-way. Rather than razing the structures or obtaining variances for each lot, the applicant chose to vacate the portion of right-of-way to address the encroachment. This vacation request will bring the structures into compliance.

Staff did not receive any calls regarding the variance application. Staff and City Plan Commission recommended approval with conditions of the vacation application. There was no public testimony at the City Plan Commission hearing.
