- Operation is 24 hours a day 7 days a week and includes 4 facilities, 24,610 spaces.

 - Surface: 787
 - Economy: 15,263
 - Park Air Express: 2,341
- Future Plans

- Contract provides Aviation with the overall management, operations and efficient collection of parking revenue for all public and employee parking facilities on airport premises.
- Responsibilities Include:
 - Accurate collection of parking fees in all facilities.
 - Provide roving patrols for customer assistance.
 - Snow removal and custodial maintenance in the lots.
 - Manage Loyalty Program.
- 5-year term
 - \$1,058,443 Average Yearly Management Fee
 - \$13,116,095 Average Yearly Operational Expenses
