## **Executive Summary**

Amending Chapter 2, Code of Ordinances, Administration, by enacting a new Section 2-11 to establish a process by which the mayor or any member of council, the clerk, the city auditor, or the city manager may seek reimbursement for legal expenses incurred in the process of seeking or enforcing an order of protection.

#### **Discussion**

This ordinance creates a new Section 2-11 of the Code of Ordinances, establishing a process for "the mayor or any member of the city council, the clerk, the city auditor, or the city manager" to request reimbursement from the City Legal Expense Fund for the seeking and enforcing of an order of protection as a result of threatening behaviors "that materially frustrates the administration of their respective office".
