Pursuant to the authority granted in paragraph (b) of Section 70-38 of the “Code of General Ordinances of Kansas City, Missouri” and subject to the provisions thereof, traffic regulations are hereby made and adopted as follows:

66815	The Paseo, E/W side, from 18 th Street south to alley	No Parking Day/ Night
66816	The Paseo, east side, from 19 th Street north to alley	No Parking 7:00 AM to 9:00 AM Monday through Friday
66817	The Paseo, west side, from 19 th Street north to alley	No Parking 4:00 PM to 6:00 PM Monday through Friday
66818	The Paseo, east side, from 19th Street south 300 feet	No Parking 7:00 AM to 9:00 AM Monday through Friday
66819	The Paseo, west side, from 19 th Street south 600 feet	No Parking 4:00 PM to 6:00 PM Monday through Friday

Reserved Parking for **Physically Disabled Persons**, as indicated below and as listed in **Sections 70-534** and **70-535** is hereby discontinued at the following location(s):

66820	Garfield Avenue, east side, from a point 57 feet south of Minnie Street then south 40 feet	Handicapped Parking
66821	Park Avenue, east side, from 190 feet north of 73rd Street then north 23 feet	Handicapped Parking
