Several hundred signs are expected to be installed, replacing temporary signs that were placed for a 90-day test and evaluation period. During the committee discussion, staff clarified that this ordinance is not related to the traffic study; rather, it will establish and post the appropriate speed limits at the designated locations. This ordinance pertains to the installation of newly constructed natural gas backup generators required for regulatory compliance and safety when wastewater crews are in the field. There are currently 31 pump stations that need backup generators; however, due to cost considerations, only 18 generators will be installed under this contract. The Council has requested additional information on the locations of the generators and the criteria used to select them before granting final approval of the ordinance. ADDITIONAL BUSINESS

1. Public Works will be giving a presentation on Impact Fees.

Nicolas Bosonetto, Public Works Department, presented. A Performance Audit completed in December 2017 found that the Arterial Street Impact Program was not functioning effectively. The City Planning team identified that the program was not properly funded and that necessary repairs were not being completed. The audit confirmed that the fee and credit system was unbalanced and not fiscally responsible for the city to continue. Following the audit, oversight of the program was transferred from City Planning to the Public Works Department, which is now using a trip-generation methodology to calculate impact fees. Previously, discounted fees established by City Council created ongoing deficits, starting from as far back as 2001. As a result, more than \$82 million in developer credits have accumulated, and impact fees have not aligned with the best interests of taxpayers. Public Works has recommended updates and adjustments, including changes to Chapter 39 and revisions to the ordinance fee structure. The Council will begin addressing these concerns by discussing them at the Developers Meeting and initiating a restructuring of the credit system.
