250925 Sponsor: Councilmember Melissa Robinson

RESOLUTION - Accepting the recommendations of the Health Sciences Community Improvement District Advisory Committee and adopting the housing improvements funds program.

Sponsors: Robinson

Erich Steyaert, City Planning Department and Allison Trottwien, Health Sciences, presented. This resolution approves the recommendations of the Health Sciences Community Improvement District Advisory Committee and officially establishes a program that uses district funds to improve housing. In simple terms, it means the city agrees with the committee's plan and is setting aside money to help repair, upgrade, or improve homes within the district.

RESOLUTION - Directing the City Manager to review best practices in peer cities related to potholes, evaluate policies in Kansas City, and make recommendations for policy improvements within 60 days.

Sponsors: Rea

Jason Waldron, Public Works Department, presented. This resolution directs the City Manager to look at how other cities handle pothole repairs, compare those methods to what Kansas City currently does, and then report back within 60 days with ideas on how the city can improve its own pothole policies and procedures.

RESOLUTION - Directing the City Manager to provide to City Council no later than December 1, 2025, a listing of programs still in existence originally funded with one-time dollars or created outside of the annual budget process.

Councilmember Andrea Bough, presented. This resolution instructs the City Manager to give the City Council, by December 1, 2025, a list of all programs that are still operating even though they were initially started with one-time funding or created outside the regular yearly budget process. In simple terms, it asks for a report showing which temporary or special-funded programs are still running.

Appropriating \$400,000.00 from the Unappropriated Fund Balance of the Public Safety Sales Tax Fund to fund design professional services for the Community Resource Center Project; authorizing the Manager of Procurement Services to execute a \$400,000.00 design professional services contract with Multistudio, Inc., for the design of the Community Resource Center; designating requisitioning authority; directing the City Manager to identify up to \$5,600,000.00 from the Public Safety Sales Tax or other fund sources for future contract amendments; and recognizing this ordinance as having an accelerated effective date.

Keeley Golden and Rukhsana Reyes, General Services Department and Councilmember Johnathan Duncan, presented. This ordinance sets aside \$400,000 from the city's Public Safety Sales Tax Fund to hire Multistudio, Inc. to design the new Community Resource Center. It also gives the City Manager permission to manage the contract and future spending. In addition, the City Manager is directed to secure up to \$5.6 million for the later phases of the project. The ordinance will take effect right away, rather than waiting the usual time frame.

Lace Kline, Mayor's office, presented. This resolution accepts the advice of the Health Sciences Community Improvement District Advisory Committee and officially approves a new program to use district funds for housing improvements. In simple terms, it means the city agrees with the committee's plan and is putting it into action so money can be used to fix and improve homes in the area.

Amending Chapter 2, Code of Ordinances, Administration, by enacting a new Section 2-11 to establish a process by which the mayor or any member of council, the clerk, the city auditor, or the city manager may seek reimbursement for legal expenses incurred in the process of seeking or enforcing an order of protection.

Mayor Quinton Lucas, presented. This ordinance amends the city's rules to add a new section that allows the mayor, any council member, the city clerk, the city auditor, or the city manager to request reimbursement for legal costs incurred in obtaining or enforcing an order of protection. In simple terms, it establishes an official way for certain city officials to be reimbursed for attorney fees incurred in protecting themselves through the court system.
