| Discussion <p>This ordinance creates a permitting process for the implementation of parklets and street cafes. A parklet is an outdoor facility located within city right-of-way which is permitted by the city to be managed by the adjacent property owner as a public space. A street cafe is an outdoor dining facility located with areas used for on-street parking which is permitted by the city to be utilized by the immediately adjacent property owner or tenant for outdoor dining as an extension of the owner's or tenant's operations.</p> | | | | | | | | | | | | | | | |
