Prohibition of <u>Parking</u> for longer than the <u>Time Limit</u>, as indicated below and as listed in <u>Section 70-531</u> and <u>70-591</u> is hereby discontinued at the following location(s):

65084	Walnut Street, west side, from a point 95 feet south of 18 th Street then south 225 feet	Three Hour Parking 7:00 AM to 6:00 PM Monday through Friday
