BUDGET MESSAGE

The Grey Oaks Community Improvement District ("District") was declared established by Ordinance No. 250513 of the City Council of Kansas City, Missouri on July 17, 2025. The District desires to fund, or assist in the funding of, certain services and improvements as allowed by Sections 67.1401 to 67.1571 RSMo.

On July 24, 2025, the District's Board of Directors passed Resolution No. 2025:03 which imposed, upon approval of the qualified voters of the District, a one percent (1%) sales tax on retail sales in the District for the life of the district for a maximum period of 20 years. The sales tax collection is anticipated to become effective in 2026.

The District has entered into a Reimbursement Agreement with Patro Brothers LLC, which will provide for formation costs, administration costs, public services and improvements within the District Project and related reimbursement.

The District has adopted a fiscal year beginning May 1 and ending April 30 of each year.
