- The Board hereby directs its legal counsel to submit to the governing body of the City of Kansas City, Missouri a copy of this resolution nominating Joel Smith, Russ Edwards, Mark Ching, Thomas Turner and Lance Tryon to serve as Successor Directors and each serving a term of four (4) years.
- Notwithstanding anything in the District's Bylaws to the contrary, Michael Burke, Robert Payne, Thomas Whittaker, John Burke, and Robert Langenkamp shall continue to serve as Directors of the District with all powers vested therein until the City of Kansas City, Missouri adopts the successor slate.
- Upon the approval of the successor slate by the Mayor and City Council, each Successor
 Director shall execute an oath of office and deliver such oath to the District's legal counsel
 to maintain with the records of the District.
