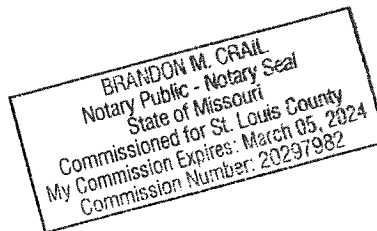

TO WHOM IT MAY CONCERN:

Pursuant to the authority granted in paragraph (b) of Section 70-36 of the Code of General Ordinances of Kansas City, Missouri" and subject to the provisions thereof, traffic regulations are hereby made and adopted as follows:

The driver of a vehicle shall **Yield The Right-of-Way** to all vehicles approaching the following intersection(s) (in the direction bound as indicated) when Yields are in place, and shall be added to the list as contained in **Section 70-316**:

Regulation 65867 Michigan Avenue and 26th Street Southbound

The following street(s) is (are) designated for a **Maximum Speed Limit** as indicated and shall be added to the list as contained in **Section 70-363**:

Regulation 65868 Metro North Drive, from N Summit Street to N Wyandotte Street 30 Miles per Hour

Regulation 65869 N Summit Street, from NW Barry Road to Metro North Drive 30 Miles per Hour

Regulation 65870 N Wyandotte Street, from NW Barry Road to Metro North Drive 30 Miles per Hour

Regulation 65876 11th Street, east side, from a point 53 feet west of Washington Street then west 88 feet No Parking Loading Zone 7:00 AM to 10:00 AM and 2:00 PM to 5:00 PM Monday through Friday

Regulation 65877 Bank Street, east side, from a point 30 feet north of 9th Street then north 80 feet No Parking Loading Zone 7:00 AM to 10:00 AM and 2:00 PM to 5:00 PM Monday through Friday

Regulation 65878 Broadway Boulevard, west side, from a point 80 feet north of 9th Street then north 40 feet No Parking Loading Zone 2:00 PM to 5:00 PM Monday through Friday

Regulation 65879 Central Street, east side, from a point 45 feet south of 10th Street then south 123 feet No Parking Passenger Loading Zone 7:00 AM to 6:00 PM Monday through Friday

Regulation 65880 Washington Street, west side, from a point 49 feet north of 11th Street then north 116 feet No Parking Loading Zone 7:00 AM to 10:00 AM and 2:00 PM to 5:00 PM

PM Monday through Friday

The locations affected by the above regulations will be marked in accordance with standards prescribed in the "Manual on Uniform Traffic Control Devices for Streets and Highways" and said regulations shall become effective five days after publication in The Daily Record.

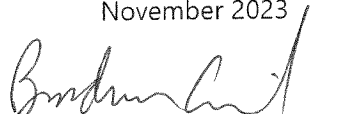
