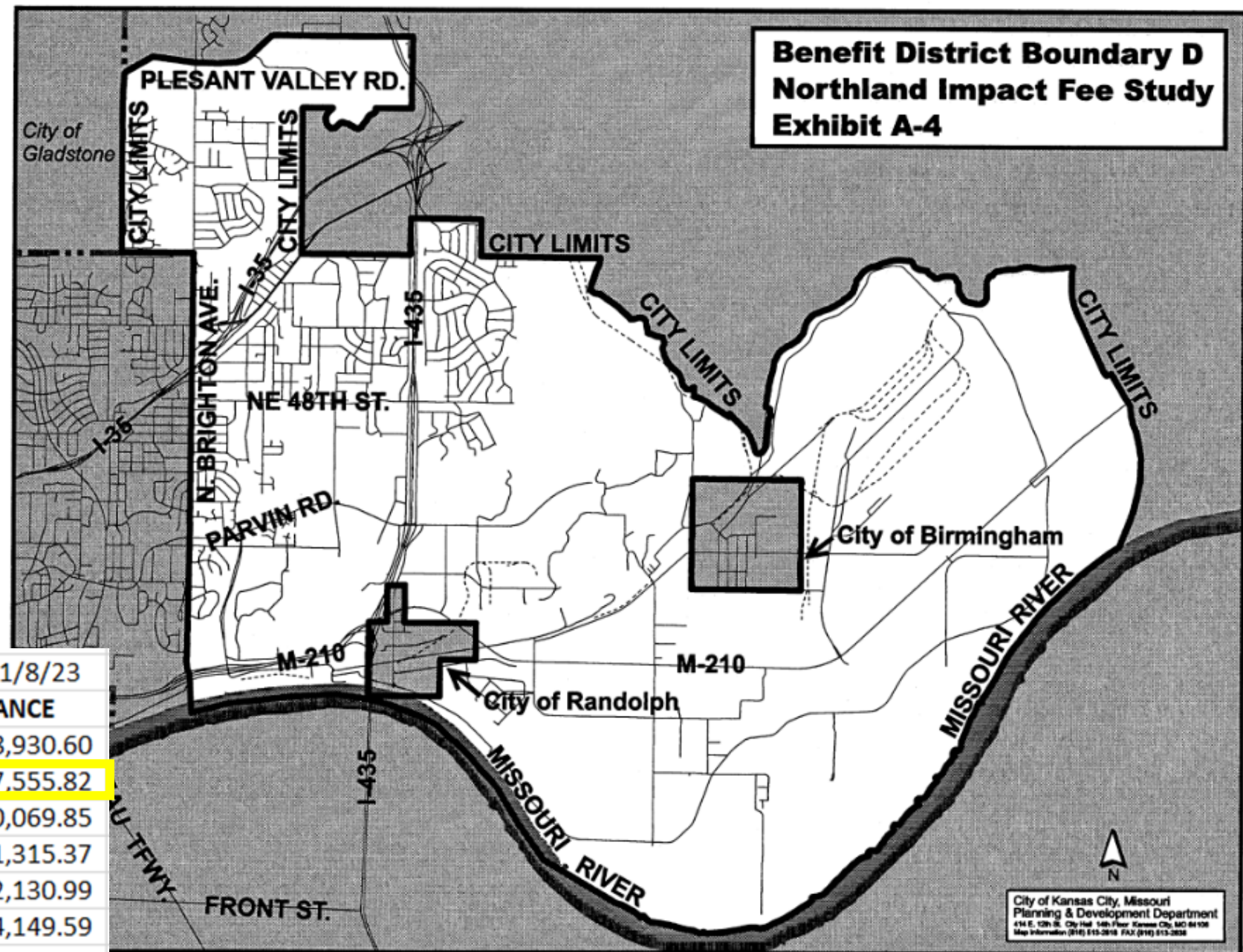

## Parvin Road TIF

- Council approved Arlington Road TIF Plan and funded it with \$9M in GO Bond funds (Ord 140916, 180418)
- Project constructed north section of Arlington Road and eastern section of 48<sup>th</sup> Street
- \$1.3 Million savings on Arlington Road proposed to be used to complete widening of 48<sup>th</sup> Street

# Ordinance 231020 - Funding for NE 48th Street

- NE 48th Street runs on the south side of the Gracemor neighborhood which is one of the largest neighborhoods in the northland that also contains Gracemor elementary school and the Gracemor park and trail.
- The roadway is a narrow 2 lane road without any turn lanes or and sidewalks. A main road to a neighborhood with an elementary school without sidewalks is a problem. In addition, the pavement is old and failing in several different places.
- In 2014, the City, the North Kansas City School District and the TIF Commission developed a plan to procure funding to make improvements to 48th Street and directed the City manager to pursue funding options. This was approved by the City Council Resolution 2015-0094.
- In 2022 Hunt Midwest began design of improvement to 48th Street at no cost to the City. We held a public meeting in July, 2022. Based on public comments and City design standards, we have completed the design which will include turning lanes and a pedestrian trail. The design also includes full pavement removal and replacement. These plans have been approved.
- Funds from the GO Bond are not additional funds. They are costs savings from N. Arlington (adjacent to NE 48th Street).
