
WHEREAS, Section 5 of the Ordinance provides an effective date of July 1, 2023; NOW, THEREFORE,

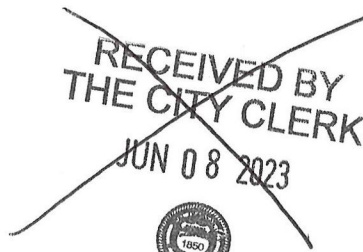
