### Northland Workforce Development Center (NWDC) Project Update

- Additional revenues identified for construction (to reduce City borrowing)
  - Surplus revenues from Northland TIF plans City portion
  - Surplus revenues from Northland TIF plans school district portion
- City Manager is directed to review options prior to issuance of the City's bonds



### Northland Workforce Development Center (NWDC) Project Update

- Additional revenues identified for debt service
  - Northland Industrial Project PILOTs (payments in lieu of tax)
    - In addition to Data Center Project PILOTs
  - Redirected economic activity taxes (EATs) from Northland Data Center Projects – as a percentage of net new revenue
    - No TIF plan; City tax redirection
    - **50%** of earnings tax and **100%** of utility tax to the extent generated



## **Updated Plan of Finance**

- Tax-exempt Special Obligation Bonds to be sold in April 2026
- Debt service to begin in FY 2027
- Contribution amount:
  - \$25,000,000 reduced from \$29.5 million
- General Fund Subsidy of up to approximately \$16.8 million (\$841,000 annually)
  - If Potential Development Projects do not meet projections, and utility tax redirections do not make up the difference
- Projected coverage ratio is **less than 1.00x** annual debt service
  - Codified Debt Policy calls for at least 1.25x



## **Updated Plan of Finance**

- Scenario 7 PILOTs and City Tax Redirection (50% earnings tax and 100% utility tax) from Expected Data Centers + PILOTs from Expected Northland Industrial / Logistics Projects
- Scenario 8 PILOTs and City Tax Redirection (50% earnings tax and 100% utility tax) from Expected and Potential Data Centers + PILOTs from Expected and Potential Northland Industrial / Logistics Projects
- Scenario 9 Scenario 8 revenues with \$29.5 million of bond proceeds

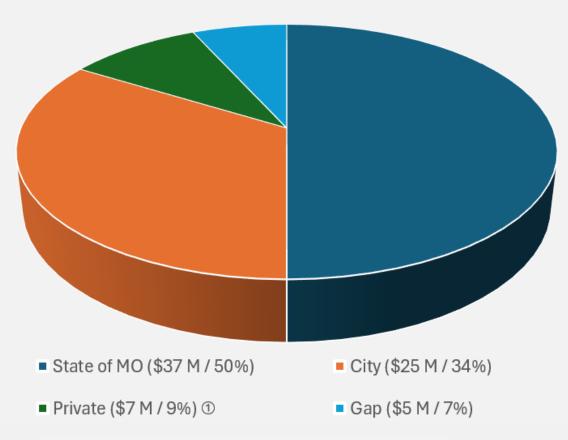

#### **Committee Substitute for Ordinance No.** 250250

- Establishes 2026A Special Obligation Projects Fund and repurposes 5250 Fund
- Estimates and appropriates **\$25 million** in special obligation bond proceeds
- Approves a Plan of Finance
- Authorizes a contribution agreement with the NWDC to provide up to \$25 million funded from bond proceeds
- Directs the City Manager to:
  - Work with the TIF Commission to identify potential surplus funds from Northland TIF Plans to reduce the City's borrowing
  - Work with the Northland School Districts to identify potential School District surplus funds from Northland TIF Plans which may be contributed



#### **Committee Substitute for Ordinance No.** 250250 (continued)

- Directs the City Manager to:
  - Utilize the various revenue sources to repay debt service
  - Replenish the City's General Fund for any subsidies, to the extent excess revenue is available
  - Reduce the amount of Northland Data Center and Industrial / Logistics PILOTs utilized to pay debt service, if not needed and the General Fund has been replenished
- Effective Date: May 1, 2025



#### **Committee Substitute for Ordinance No.** 250250 (continued)

- Potential agreement shall include the following conditions:
  - City has no responsibility for operations and maintenance of the facility and no legal liability related to the facility
  - City has ability to use the NWDC for community meetings, trainings, career fairs, etc., free of charge
  - No less than 2/3rd of the student population of the NWDC shall live within Kansas City's corporate limits
  - NWDC will provide a **discounted tuition rate for City employees**

# **Expected Development**

- **Expected Development** include buildings that range from occupied to those that have building plans under review. We are **most confident** about these revenues.
- Data Center PILOTs
  - Includes the City's portion (19-21% of PILOTs) for
    - 3 building/halls for Golden Plains Technology Park
    - 2 buildings for Shalerock
    - 1 building for Rocky Branch Creek Technology Park
- Data Center City Tax Redirection
  - 50% City Economic Activity Tax (EATs) Redirection
- Northland Industrial PILOTs
  - Includes Hunt Midwest Phase I, II, and VI, JCT Warehouse, KCI 29 Logistics Park Phase I, Niagara Bottling (Facility and Equipment)

# **Potential Development**

• **Potential Development** includes buildings that are on development plans that have been approved by Council, but the timeline for construction **is unknown and speculative**.

#### Data Center PILOTs

- Includes the City's portion (19-21% of PILOTs) for
  - 3 additional building/halls for Golden Plains Technology Park
  - 2 additional buildings for Shalerock
  - 4 additional buildings for Rocky Branch Creek Technology Park
- Data Center City Tax Redirection
  - 50% City Economic Activity Tax (EATs) Redirection
- Northland Industrial PILOTs
  - Congress Industrial, Tiffany Springs Logistics

## **Potential Risks and Issues**

- The Potential Development **may not occur** in total or in part, which would impact the City Tax Redirection and Data Center PILOTs and Northland Industrial PILOTs
- Projected General Fund subsidy of \$16.8 million (\$841,000 annually)
  - With FY 26 Adopted Budget, General Fund is just at the three-month (25%) target no additional flexibility available without cuts to expenditures
  - Removes future flexibility
- Voters may not renew certain taxes which would impact the City Tax Redirection
  - Earnings Tax Expiration 12/31/26 **Subject to renewal every 5 years** 10-year stepdown if not renewed
