


Modifications to the Plan - Overview

- Increases Total Project Costs by \$14,869,303.
 - \$7,578,303 increase to Reimbursable Project Costs
 - \$7,318,000 Increase to Other Sources
- Moves Project 7c to the Current Project List.
- Current Projects 3/4/7a/10/6/TS1/11 increase total Budget and Reimbursable Project costs by \$518,000
- Added Trail Segment 6
- Added Trail Segment 7



- Project 7a
 - Added Design Cost of \$500,000
 - \$100,000 Other Sources
 - \$400,000 Reimbursable project Costs
- Project 7b
 - Added Design Cost of \$500,000
 - \$100,000 Other Sources
 - \$400,000 Reimbursable project Costs



- Project 10
 - Reduce length of water extension 1,091 ft
 - Reduce Reimbursable Project Cost by \$304,697
- Project 12
 - Modified Description of Improvement to include Mass Grading
 - Added Site Work (South of Tiffany Springs RD) \$1,595,708
 - Added Mass Grading & Design Costs \$106,000
 - Contingency removed; soft costs added \$82,907
 - Total increase to Reimbursable Project Costs \$1,900,708




- Project 13
 - Reduces Reimbursable Project Costs for Site Work by \$2,342,168
 - Reduces Reimbursable Project Costs for Contingency by \$415,000
- Project 14
 - Costs adjusted across line items; detail added
 - No increase or decrease to Project Costs.



- Twin Creeks Trail System
 - Added Trail Segment 6 and Trail Segment 7
 - Total increase of \$6,818,000 in Project Costs from Other Sources
 - Reimbursable Project Costs of \$508,000 and \$154,000 were Applied to TS3 & TS4 in the 7th Amendment. \$508,000 is now applied to TS2, and \$154,000 applied to TS3.
