Re: Ordinance No. 250639

Dear Mayor Pro Tem and Committee Members:

Plaza Westport Neighborhood Association (PWNA) is asking the Neighborhood Planning and Development Committee to consider a Committee Substitute for Ordinance No. 250639. This is consistent with the City Planning staff's recommended alternative revised text amendment. And this alternative was considered and recommended by the City Plan Commission (CPC) when it heard Case No. CD-CPC-2025-1027.

The PWNA recommends Committee Substitute for Ordinance No. 250639 for 3 reasons:

- <u>keep the "Seville West" site within the defined "Country Club Plaza"</u> of Zoning Code Section 88-810-395, but update the height for the subject parcel as codified in the Zoning Code Section 88-120-04-B, including Table 120-2;
- <u>retain the prohibition of nuisance uses</u> that would otherwise be permitted if the Seville West site was taken out of the Zoning Code defined area of the Country Club Plaza; and
- <u>amend where office uses are allowed</u> to give added flexibility to adapt the Plaza to current demand and needs.

PWNA remains concerned about the proposed alternative height amended from 130 feet to 275 feet at the Seville West site that may encourage more requests to add height. PWNA worked hard, alongside others, to obtain the height safeguards in Ordinance No. 190100, and believes that those heights set for the Plaza Bowl Overlay District should remain in place to provide a reliable basis for future development and investment by both commercial and residential uses. Our main concern is for the architectural significance and heritage of the Country Club Plaza.
