Executive Summary

Authorizing the Manager of Procurement services to execute a one-year contract renewal (6224020014) in the amount \$1,942,859 with LAZ Parking Midwest, LLC to continue performing Curbside Traffic Management and Traffic Control responsibilities; and authorizing the Manager of Procurement services to amend and renew the contract for up to four (4) additional one-year terms with City Council authorization.

Discussion

The Kansas City Aviation Department Airport Police enforces traffic control and prevention of curbside parking. This contract supports those operations and will provide supplemental work force to conduct traffic control and enforcement.
